

THE HELM at Deemer's Landing

- 1. APPLICATION PROCESS IS BASED ON THREE PARTS:
 - a. Employment verification and/or income verification
 - b. Present and previous landlord/mortgage verification
 - c. Credit history and criminal background check
- 2. APPLICANT MUST BE (21) YEARS OF AGE OR OLDER TO LEASE & RESIDE HERE
- 3. MUST SUMBIT WITH APPLICATION:
 - a. Two (2) of current paystubs/tax returns (2 years)/ or proof of income
 - b. Must show photo ID to submit application
 - c. Application fee \$50.00 per applicant
- 4. RENT SHALL NOT EXCEED 30% OF MONTHLY INCOME
- 5. MUST SUBMIT A HOLDING FEE OF \$500.00 TO HOLD AN APARTMENT:
 The Holding Fee of \$500.00 is non-refundable after (5) days. Holding Fee is refundable ONLY when: (a) application has been denied OR (b) the apartment is not available upon scheduled delivery date OR (c) applicant cancels in WRITING within (5) days of submitting an application.
- 6. RENTER'S INSURANCE IS REQUIRED: \$500,000 liability insurance must be maintained for the duration of your residency.
- 7. TENANT'S ARE REQUIRED TO PAY UTILITIES. (Electric, gas heat, cable, telephone, etc.)
 - A) ONCE APPROVED: Applicant will need the following documentation at lease signing: (a) Delmarva account number for gas heat (b) METER deposit receipt from Municipal Services for electric service and (c) proof of renters insurance. \$500,000.00 Liability Coverage, \$25,000.00 Personal property coverage, \$5,000.00 medical coverage, Endorsement for backup of Water & Sewer, and Landlord MUST be listed as an additional insured
- 8. ANYONE (18) or older: that will be listed as an occupant on the lease must submit an application for the leaseholders file. All persons (18) or older must be screened before residing in our community. Management reserves the right to deny an application if a criminal record is found. Anyone moving onto the property without our approval or consent will be considered UNAUTHORIZED and will be asked to leave immediately.
